Dear Customers!

Herewith we would like to confirm that LLC “Brooklyn-Kyiv Port” (hereinafter referred to as the Terminal) at the given moment, notwithstanding all restrictions imposed under present circumstances continues to work and respect its commitments to all contracted clients including those involving house-keeping and outside expenditures of the company. Due to martial law and navigation blockade in Black Sea water area, the Terminal has accumulated a vast number of containers with a bulk quantity of strategic cargoes. With knowledge of importance and relevance of such cargoes for Ukraine citizens and to accede to the needs of Ukrainian Armed Forces as well as to realize international contracts of Ukrainian business, taking into consideration the level of risk the Terminal is exposed to being an important infrastructure facility, the Terminal Administration since the first days of the war and up to now are doing their utmost to provide for uninterrupted cycle of cargo handling and delivery to the customers and to make a range of cargo inspection operations for Ukrainian Armed Forces at company’s own expense.

As a consequence of termination of income-generating business (vessel handling), the Terminal is facing financial hardship, still it continues to provide maximum possible support to its customers and Ukrainian Armed Forces. Thus, in view of legal status of martial law which became effective on 24.02.2022, until now the Terminal has not been charging for storage of all containers in the company yard. But in light of the current difficult situation **the Terminal is forced to resume charging for storage of export, import and empty containers starting from May 16, 2022.** Charging for container storage will be done according to existing tariffs stipulated in Addendum 1 to your current contract. Storage days will be calculated starting with the day of arrival of a container to the Terminal excluding the period from 24.02.2022 through 15.05.2022 (81 days of free storage). For example, an import container arrived at the Terminal on February 20, 2022 and was released on May 20, 2022 – so, the number of paid storage days will be 8 days (3 days in February and 5 days in May).

Kindly ask you to take the above information into consideration and use it in your workflow management.
